To: Business Owner or Property Manager RE: NEW Solid Waste Collection Services Starting December 1, 2021

Dear Valued Athens Customer,

The City of Glendale awarded Athens Services the exclusive contract to provide recycling, organics, and solid waste collection services for businesses and multi-family buildings in your area. *Starting the week of December 1, 2021, the new waste collection service will commence and new containers, where necessary, will be delivered.* 

As part of the new solid waste service program, the City of Glendale is requiring businesses and multi-family buildings to have separate recycling (blue), organics (green), and trash (black) containers, similar to existing residential services. In compliance with California Senate Bill 1383, all businesses and residents will be required to source-separate their recycling, trash, and organics waste (including food scraps).

#### Service Level Changes

For customers who want to make changes to their current service level, including adding the required recycling and organics containers, please call Athens' Customer Care Center at (888) 336-6100. Container dimensions can be found by visiting <u>AthensServices.com/Container-Sizes</u>.

#### **Bulky Item Collection Change**

Customers are allowed four (4) free collections per calendar year; additional collections are subject to charges. Each bulky item collection can include up to four (4) large household items OR up to ten (10) bundles of Green Waste (no more than 4' long and 18" in diameter). Each individual item cannot be larger than what two people can safely handle. Collections will happen on scheduled pick up days and must be reserved at least 2 days in advance. #### TAKE IT A STEP FURTHER

- Create a printing policy. Print double-sided, print only when necessary, collect scrap paper, and use at least 30% recycled content paper.
- Implement reusable serving-ware and bulk snacks and condiments in your kitchens to cut down on single-use.
- Establish written Zero Waste goals and an Environmental Purchasing Policy.
- Conduct random visual audits of your containers to check for contamination and diversion opportunities.

## HOW TO HANDLE BATTERIES

It is illegal to place batteries in your waste bins. Batteries should be disposed of as hazardous waste. They can spark fires or create an unsafe environment for waste workers. If properly collected, battery recyclers can repurpose the metal.

#### Storage tips to avoid short-circuiting and fires:

- Place a piece of non-conductive tape or duct-tape on the ends. Do not cover the brand name or chemistry of the battery.
- Store batteries in a container that does not conduct electricity (like plastic, cardboard, or glass).

#### NOTICE OF IMPLEMENTATION OF A WASTE HAULING FRANCHISE REQUIREMENT FOR THE SERVICING OF COMMERCIAL ACCOUNTS IN THE CITY OF GLENDALE

Dear City of Glendale Business/Property Owner:

This letter is to notify you that an exclusive franchise system for collection and hauling of solid waste for all commercial properties (including all businesses and multi-familybuildings with five or more units) in the City of Glendale has been implemented citywide with an effective completion date to transition to the new franchise hauler by **December 1, 2021**.

This change follows an extensive planning period started in July 2013 in anticipation of State mandates that require recycling and organics diversion at all properties. Public outreach and community forums began to take place over the summer of 2017, and the commercial franchise system was discussed in a public forum by the Glendale City Council on five separate occasions between September - July 2021. On July 27, 2021, the Glendale Municipal Code (GMC Chapter 8.56) was amended to establish an exclusive franchise system for solid waste collection service of commercial establishments and multi-family residential properties. The exclusive franchise system will further sustainability goals, bring improvement to the environment by reducing solid waste traffic, emissions, and street impacts, and allow the City to meet additional mandates by the State of California related to recycling and organics diversion.

What does this mean for you? Refuse, recycling, and organics collection services for commercial properties will be provided by the franchise hauler that was assessed and selected by the City through a competitive process.

Your current hauler has been formally notified of this change, and should be cooperating with your new haulerto ensure a smooth transition between service providers.

**You are in Franchise Zone B. Your new franchised hauler is Athens Services**, and you are required to subscribe to service with them no later than November 30, 2021 with your new service beginning on December 1, 2021. Athens Services will be charging you rates limited to a maximum set by the City, and attached to this letter (See Attachment 1). New and expanded programs and services are included under this new franchise and rollout of these services will occur in the near future.

This hauler has been serving the City independently for many years and will take great pride in enhancing the quality of your collection services. As part of the new franchise agreement with the City, you are eligible to receive a free, on-site consultation to ensure the best possible level of service and assist your business/property comply with recently-enacted State mandates to reduce waste and increase sustainability efforts.

Recycling and organics service is required for all customers in Glendale, in accordance with the City's municipal code and State law. You may be able to reduce the size or frequency of your refuse service when yousign up for recycling and organics service; please work with your new hauler to ensure that you have enough service to properly sort your materials into the refuse, recycling, and organics containers and so that there is no overflow from your containers.
